#### PLAINTIFFS-APPELLANTS' SUPPLEMENTAL BRIEF

This appeal remains justiciable. It is an issue raised by Appellees in a footnote and it is without basis. That said, as this Court requested supplemental briefing regarding "whether this case has now been mooted by the occurrence of events since this appeal has been filed" (Order of Aug. 7, 2024), Appellants would highlight that the need for a preliminary injunction is ever more pressing than it has been.

### 1.0 Matter Developments

As the Court is aware, Plaintiffs-Appellants Meredith O'Neil, Jessica Svedine, Deanna Corby, and Roberto Silva<sup>1</sup> believe that Karen Read, a member of their local community, is being framed for the murder of her boyfriend, Boston Police Officer John O'Keefe. Verified Complaint AA003 at ¶ 1. The prosecution is pending in the Norfolk County Superior Court, styled *Commonwealth v. Karen Read*, Docket No. 2282CR0117.

To protest perjury in Read's prosecution, Appellants and other members of the public gathered on Sunday, November 5, 2023, across the street from Chris Albert's business, D&E Pizza. AA007 at ¶ 29. At that protest, Appellants held signs that had inoffensive slogans like "Free Karen Reed" and "Justice." *Id.* at ¶ 30. Appellees Officers Robert Zepf, Michael Chin, and Anthony Pascarelli, and Sgt.

Joseph Silvasy, members of the Canton Police Department, drove by the protest several times, attempting to intimidate the protesters into leaving. *Id.* at ¶ 31. These Appellees are supervised by Appellee Rafferty and necessarily act at her direction. AA008 at ¶ 33. When Appellees' intimidation tactic proved unsuccessful, Officers Robert Zepf, Michael Chin, and Anthony Pascarelli, and Sgt. Joseph Silvasy stopped and informed the protesters that they were not permitted to protest there, because if the protest could be seen by Chris Albert, they would deem it to be "witness intimidation" and Appellants would be arrested. *Id.* at ¶ 34. The officers specifically handed Appellants a copy of Mass. Gen. Laws, ch. 268, § 13A, the statute under which they threatened Appellants. *Id.* at ¶ 35.

Following the denial of injunctive relief below, Appellees made good on their threats and charged some of the Appellants with violation of the Massachusetts witness intimidation statutes, Mass. Gen. Laws, ch. 268, §§ 13A & 13B. *Canton Police Dept. v. Corby*, Docket No. 2355AC001047 (Stoughton Dist. Ct.); *Canton Police Dept. v. O'Neil*, Docket No. 2355AC001043 (Stoughton Dist. Ct.); *Canton Police Dept. v. Silva*, Docket No. 2355AC001044 (Stoughton Dist. Ct.). On August 2, 2024, these charges were dismissed for lack of probable cause. *See* Exhibit 1,

Declaration of Meredith O'Neil ("O'Neil Decl.") at ¶¶ 6-7; Exhibit 2; Exhibit 3, Declaration of Deanna Corby ("Corby Decl.") at ¶¶ 6-8; Exhibit 4; Exhibit 5, Declaration of Roberto Silva ("Silva Decl.") at ¶¶ 6-8; and Exhibit 6.

In the intervening months, the trial of Karen Read was held. *See* Exhibit 8. However, a mistrial occurred, and a second trial is set for January 27, 2025. 3 *Id.* Although a motion to dismiss is pending on Double Jeopardy grounds, it is only as to Counts 1 & 3 against Read. *See* Exhibit 9. Thus, even if the motion is allowed, trial will proceed on Count 2—the manslaughter charge—which necessarily requires the jury to find that Read caused the death of O'Keefe with her vehicle, rather than some other person.

Plaintiffs-Appellants intend to continue protesting what they believe to be the framing of Karen Read. *See* O'Neil Decl. at ¶ 3; Corby Decl. at ¶ 3; Silva Decl. at ¶ 3; and **Exhibit 10**, Declaration of Jessica Svedine ("Svedine Decl.") at ¶ 3. However, they remain fearful of doing so where they have already been wrongly charged merely because their protest, at the busiest intersection in Canton, across from where Read and O'Keefe met up that fateful night, could be seen by a single witness. *See* O'Neil Decl. at ¶ 4; Corby Decl. at ¶ 4; Svedine Decl. at ¶ 4; Silva

Decl. at ¶ 4; see also Exhibit 7 (observing that the basis for the charges was that the protest might happen to be seen by Chris Albert, a witness, because his business was, coincidentally, next to where Read and O'Keefe met up). Their fear is heightened because, unless Defendants-Appellees are instructed and enjoined from attempting to apply Sections 13A and 13B against them, they will once again have to face the prospect of bogus charges.

#### 2.0 The Matter Remains Justiciable

Neither the case nor the instant appeal seeking reversal of the denial of a preliminary injunction are moot.<sup>4</sup> The denial remains ripe for review.

At the outset, to the extent there may be any question as to whether the case before the District Court is moot, it is not. In their Verified Complaint, Plaintiffs-Appellants seek an award of money damages for violation of their constitutional rights. AA010 & AA013. When a "plaintiff seeks alternative redress (such as money damages) in addition to injunctive relief, the occurrence of the watershed event may not render the controversy moot." *Me. Sch. Admin. Dist. No. 35 v. R.*, 321 F.3d 9, 17 (1st Cir. 2003). Thus, even were the Court to determine that the claims for declaratory and injunctive relief were moot on account of the

developments in the *Read* case, the claim for money damages for the violation of rights a court has already determined was without probable cause remains.

However, the claims for declaratory and injunctive relief, including the request for a preliminary injunction, are not moot. In their principal brief (p. 15, n.11), as cited by the Court, Appellees solely argue that the requested preliminary injunction "is now moot as the anticipated date of Appellants' planned protest has long past and Chris Albert has already testified." When a defendant asserts mootness, "it bears the heavy burden of persuading the court that there is no longer a live controversy." *Friends of the Earth, Inc. v. Laidlaw Envtl. Services (TOC) Inc.*, 528 U.S. 167, 189 (2000); *Conservation Law Found. v. Evans*, 360 F.3d 21, 24 (1st Cir. 2004) (finding that the party invoking the doctrine of mootness has the burden of establishing mootness). A claim is not moot unless it is "absolutely clear that the allegedly wrongful behavior could not reasonably be expected to recur." *United States v. Concentrated Phosphate Export Ass'n*, 393 U.S. 199, 203 (1968).

Appellees do not admit Appellants had the right to protest. They were told their protests would violate (albeit without probable cause) Section 13A. "When an individual is subject to such a threat, an actual arrest, prosecution, or other enforcement action is not a prerequisite to challenging the law." *Susan B. Anthony List v. Driehaus*, 573 U.S. 149, 158 (2014) (first citing *Steffel v. Thompson*, 415 U.S. 452, 459 (1974); and then citing *MedImmune, Inc. v. Genentech, Inc.*, 549 U.S. 118,

128–29 (2007)). The law does not "require a plaintiff to expose himself to liability before bringing suit to challenge the basis for the threat." *MedImmune*, 549 U.S. at 129. Failure to disavow future prosecution is fatal to a claim of mootness. *See N.H. Lottery Comm'n v. Rosen*, 986 F.3d 38, 54 (1st Cir. 2021). There are no assurances that, the next time Appellees protest at that same corner, in the same manner, one or more of the appellees will not again make a threat of prosecution in derogation of the First Amendment.

Appellants' motion sought injunctive relief to permit "peaceful protest" on November 12, 2023, "and thereafter" to "avoid the threat of arrest[.]" AA035. The precise terms of the proposed order (AA052) sought to enjoin Appellees "from enforcing Mass. Gen. Laws, ch. 268, §§ 13A & 13B, to the extent it would interfere with Plaintiffs' demonstrations regarding the Karen Read prosecution based solely on Plaintiffs' otherwise lawful speech so long as Plaintiffs do not engage in the blocking, impeding, inhibiting, or in any other manner obstructing or interfering with access to, ingress into and egress from any building or parking lot of the business they plan to protest." Although the initial trial has ended, the prosecution has not. Appellees intend to protest once an injunction enters. See O'Neil Decl. at ¶ 5; Corby Decl. at ¶ 5; Svedine Decl. at ¶ 5; Silva Decl. at ¶ 5. And, there is nothing to suggest Chris Albert would not, once more, be a witness for the retrial. Suppressing the protests is part of the prosecution's strategy—as set forth in the Incident Report,

Appellees were dispatched on the direction of the Norfolk County District Attorney's Office Special Prosecutor (prosecuting Read). *See* Exhibit 7. The purpose of the demonstrations remains a live issue. Similarly, neither Section 13A nor Section 13B are restricted to a pre-verdict timeframe—Appellants risk arrest for lifetime of Mr. Albert and every other witness who may pass by.

As Appellants observed in their Reply Brief at 11-12, "[s]imply stated, a case is moot when the issues presented are no longer 'live' or the parties lack a legally cognizable interest in the outcome." *D.H.L. Assocs., Inc. v. O'Gorman*, 199 F.3d 50, 54 (1st Cir. 1999) (quoting *Powell v. McCormack*, 395 U.S. 486, 496 (1969)) (internal quotation marks omitted). "Another way of putting this is that a case is moot when the court cannot give any 'effectual relief' to the potentially prevailing party." *Horizon Bank & Trust Co. v. Massachusetts*, 391 F.3d 48, 53 (1st Cir. 2004) (citing *Church of Scientology of Cal. v. United States*, 506 U.S. 9, 12 (1992)). The relief sought—enjoining enforcement of Sections 13A and 13B as against Appellants' specific protests—enforcement that has been deemed to be without probable cause—would be effectual relief.

In its order, the Court requested the parties address relevant caselaw, including Renne v. Geary, 501 U.S. 312 (1991), Susan B. Anthony List v. Driehaus, 573 U.S. 149 (2014), D.H.L. Assocs., Inc. v. O'Gorman, 199 F.3d 50 (1st Cir. 1999), and

Horizon Bank & Trust Co. v. Massachusetts, 391 F.3d 48 (1st Cir. 2004). These cases all support Appellants and dictate that the matter is justiciable.

In *Renne*, the Supreme Court determined that a declaration of a statute's invalidity might not redress the injury claimed by the plaintiff-voters. 501 U.S. at 319. Here, a declaration of unconstitutionality and injunction of Sections 13A and 13B, as-applied, would enable Appellants to resume their protest activities at the intersection. The *Renne* Court also determined injunctive relief was not ripe because there was no record of an actual or imminent application of the statute. *Id.* at 320-22. In contrast, the Read prosecution is ongoing, and Appellees have not withdrawn their position that engaging in the same protest as planned would not (again) result in charges for violation of the statutes. Thus, *Renne* does not support Appellees.

Susan B. Anthony List fully supports Appellants. Like the petitioners in that matter, Appellants have suffered an Article III injury in fact. They have pleaded the specific statements they would make—the course of conduct arguably affected with a constitutional interest. Compare Susan B. Anthony List, 573 U.S. at 161. Their future conduct is arguably proscribed—Defendants-Appellees, at the behest of the Special Prosecutor, have already determined it is. Compare id. at 162. And, the threat of future enforcement is substantial, as "past enforcement against the same conduct is good evidence that the threat of enforcement is not chimerical." Id. at

164 (quotation marks and citation omitted). Thus, *Susan B. Anthony List* supports Appellants.

Similarly, the case is ripe as "prospective enforcement of an ordinance has been found sufficient to generate a live case." *D.H.L. Assocs.*, 199 F.3d at 54. Here, Appellants, were they to undertake the same speech, are likely to again face charges under Sections 13A & 13B. And, unlike with respect to the superseded ordinances in *D.H.L. Assocs.*, this case and this appeal are not moot because a) the statutes have been enforced against Appellants, and b) they have not been repealed. 199 F.3d at 55. Thus, *D.H.L. Assocs.* supports a finding of justiciability.

In *Horizon Bank & Trust Co.*, the appeal was deemed moot because the Commonwealth had no remaining legally cognizable interest in the funds at issue. 391 F.3d at 53-54. Here, Appellants have a cognizable interest in preventing enforcement of the statutes against their speech. Although, as noted in *Horizon*, "a case not moot at the outset can become moot because of a change in the fact situation underlying the dispute, making relief now pointless" (*id.* at 53), such is not the case here. Although Albert has testified, relief is not pointless because Albert will likely testify again. And, as noted above, there is no statutory cutoff time. Once a witness, always a witness. If Read is convicted on retrial, ongoing protests against wrongful imprisonment would still be in view of Albert or any other witness driving by. Thus, the requested relief is not moot.

### 3.0 Conclusion

In light of the foregoing, the Court should determine that the underlying action and this appeal are not moot. Appellants remain under a real threat of an unlawful enforcement of Sections 13A and 13B, without probable cause, were they to resume their planned protests. The order denying the preliminary injunction should, therefore, be reversed.

1.) On November 5, 2023 I, Officer Zepf, was dispatched along with Sgt. Silvasy, Officer Pascarelli, and Officer Chin to the vicinity of D&E Pizza for a report of picketers gathering across the street. This information was called into Canton Police by the Norfolk County District Attorney's Office Special Prosecutor. Through consultation with members of Canton Police and others it was determined that the protestors may be in violation of MGL 268 13A which states: Whoever, with the intent of interfering with, obstructing, or impeding the administration of justice, or with the intent of influencing a witness in the discharge of his duty, pickets or parades in or near a building housing a court of the Commonwealth, or in or near a building or residence parades in or near a building housing a court of the Commonwealth, or in or near a building or residence occupied or used by such witness, shall be punished by a fine or imprisonment for not more than one year, or both. MGL 268 13A was photo-copied and brought to distribute to those picketing on scene.

- 2.) When we arrived Officer Chin was audio and video recording the encounter with his cruiser laptop. I introduced myself and informed those present that we were video and audio recording the encounter. I advised those present that they were in violation of MGL 268 13A (Picketing Court, Judge, Juror, Witness, or Court Officer) because of their proximity to D&E restaurant, which is owned and operated by ALBERT, Christopher. ALBERT was present on this day, at the restaurant, while the protesters were picketing in front of the restaurant. ALBERT is currently a victim/witness in an ongoing court case out of Stoughton District Court involving Aiden Kearney, also known as "Turtleboy".
- 3.) I distributed the information we had prepared and was met with skepticism and disbelief of the law and their behavior pertaining to thee law. I advised them that being in this close of a proximity (across the street, within eyesight, approximately 50-60 feet away) was a violation of the statute. I asked for names of those present, no one complied. I was met with disdain and contempt, many present stated they didn't need to give their name and refused to give their names. The crowd refused to leave when instructed to do so. They continued to argue over the language of the statute and how it pertained to the current situation. There were several signs being held, stating "free Karen Read", "free turtleboy" and "Colin was in the house".
- 4.) Officer Chin continued to record the event and captured all vehicles present in the Walgreens lot in an attempt to ascertain the identities of those present in the future. Officer Pascarelli also spoke with the victim, Chris Albert, and will be filing a supplemental narrative.
- 5.) This matter continues to be investigated by the Canton Police.
- 6.) Officer Pascarelli was able to identify Bradford(Michael D.), Corby (Deanna M.), O'Neil (Meredith A.), Rocco (Nicholas), and Rocco (Jenna), Silva (Roberto), Enos (Jessica A.). I was able to identify Braley (Robin) and Braley (Keith) from prior calls with Canton Police. Duggan (Timothy M. Jr.) was identified with help from the Canton Police tip line.
- 7.) This matter will be sent to Stoughton District Court and all offenders named will be charged with MGL 268 13A (Picketing a Court, Judge, Juror, Witness, or Court Officer).

This is a supplemental report. On Sunday, November 5, 2023, I was assigned the East sector for the 7:45am –
3:45pm patrol shift in fully marked cruiser CAN686. At approximately 1:30pm, I was dispatched to the area of
Washington St by Bolivar St for a report of picketers in violation of Massachusetts General Laws: Chapter 268
Section 13A.

- 2. Upon my arrival with Sergeant Silvasy, Officer Zepf, and Officer Chin, we were met with approximately 10 people holding signage on the sidewalk directly across the street from D & E Pizza & Subs located at 618 Washington St Canton, MA owned by ALBERT, Chris. Officer Chin video/ audio recorded the interaction using CAN686's cruiser mounted laptop unit. My WatchGuard microphone was activated during the encounter. The signage that individuals were holding referenced an ongoing criminal investigation involving defendant Karen Read. Several paper copies of Massachusetts General Laws: Chapter 268 Section 13A were handed out to some of the individuals involved. The picketers were explained that they could not be in view of D & E Pizza & Subs, as Chris Albert was inside, who is a named witness in an open case involving Aidan Kearney a/k/a Turtle Boy, while picketing. ALBERT has also testified in front of a grand jury and is a named witness in an open case involving defendant Karen Read.
- 3. Officers asked the individuals involved in the picketing for their names due to the offense but they refused to give that information. After we cleared the scene, Officer Chin and I, who were both in fully marked cruiser CAN686, ran license plates of vehicles in the area including in the nearby parking lot of restaurant Waterfall Bar and Grill as well as some vehicles on Washington St that were in the area. Officer Chin was able to video record (using cruiser CAN686's cruiser mounted laptop unit) license plates of vehicles parked in the nearby parking lot of Walgreens which were subsequently ran and used to determine the identities of the individuals involved by comparing driver's license photographs to the video footage of the incident taken by Officer Chin. This was done in an attempt to identify the individuals involved in order to assist the investigation so that criminal charges could be filed because those involved refused to provide officers with their identifying information for violating Massachusetts General Laws: Chapter 268 Section 13A. Officer Chin downloaded the video footage he took using cruiser CAN686's cruiser mounted laptop unit to a USB drive and gave it to Lieutenant Lank who entered it in as evidence for this case.
- At time 1348hrs I ran 3 license plates that were parked near each other in the far rear side of the Waterfall Bar and Grill parking lot. These plates were MA REG: (owner: ROCCO, Nicholas), MA REG: (owner: CORBY, Deanna), MA REG: (owner: BRADFORD, Michael) due to it being video recorded in the parking lot of Walgreens during the time of the picketing. BRADFORD could be seen in the video that Officer Chin took wearing a sweatshirt with a picture of Officer John O'Keefe, blue jeans, black hat, and holding a sign that stated "Free Karen Read." ROCCO, Nicholas is identified in the video that Officer Chin took as wearing a dark colored sweatshirt that states 'FREE KAREN READ' as well as grey sweat pants and a dark colored hat with dark colored facial hair holding a sign that says 'FREE TURTLEBOY.' BRALEY, Robin can also be seen in the video that Officer Chin took wearing a light colored blue-ish sweatshirt that states 'FREE KAREN READ' as well as dark colored pants, red-ish hair, sunglasses, while holding a sign that says, 'FREE KAREN READ.' CORBY, Deanna can also be seen in the video that Officer Chin took wearing a Red Sox baseball hat, lighter colored blue/grey-ish

sweatshirt stating, 'FREE KAREN READ' dark colored pants, purse, holding a sign that states, 'FREE KAREN READ.' Also in the video that Officer Chin took, BRALEY, Keith can be seen wearing a maroon colored sweatshirt that states, 'FREE TURTLEBOY,' blue jeans, a silver watch on his left wrist, grey goatee facial hair, and a bald head. He was holding a sign that stated, 'FREE KAREN READ.'

- I spoke with ALBERT, Chris inside of the restaurant. He informed me that several individuals were out on the sidewalk in front of the restaurant near the entrance while holding signs and chanting. When ALBERT opened the door, he stated that he could hear them screaming. He then stated that an individual put the sign onto the window of his restaurant that said, "Colin Albert was inside the house." ALBERT stated the individual was approximately 20 years old with light blonde hair and ALBERT was able to videotape him. He was later identified as DUGGAN, Timothy by police. 'Colin Albert' is the son of ALBERT, Chris. There are some citizens that believe that Colin Albert had an involvement in the death of John O'Keefe.
- 6. ALBERT mentioned another individual he knew of who was holding a sign by the name of 'Jenna Rocco.' He states that she 'runs everything for 'Turtle Boy'' A/K/A Aidan Kearney. ALBERT stated that he told her that she cannot do that because he is a named witness. ALBERT also mentioned a blonde female that came close to the window and kept saying that Colin was in the house and called ALBERT a murderer. He stated this individual had black glasses, a green jacket, and a sign that said 'Colin Albert was in the house.' She was later identified as ONEIL, Meredith. In the video that Officer Chin took, ONEIL can be seen matching the above description stated by ALBERT. She can also be seen holding a sign that states, 'COLIN ALBERT WAS INSIDE THE HOUSE' followed by an image of Colin Albert.
- ALBERT sent video footage and photographs to my police department email address. The video, taken by ALBERT, depicts the female identified as ROCCO, Jenna wearing a 'FREE KAREN READ' blue sweatshirt, jeans, and boots while holding a sign that states "FREE KAREN READ." It also depicts DUGGAN as an approximately 20-year-old male with light blonde hair wearing a dark colored sweatshirt stating 'JACKSON/YANNETTI 2024', grey sweat pants, and sandals holding a sign that reads on the back, "guess what?" and on the front states, "Colin Albert was inside the house" followed by a picture of Colin Albert. These individuals were holding the signs outside of the restaurant and then turn to confront ALBERT. DUGGAN then states to ALBERT, "take a picture it will last longer, bud." Then ALBERT states, "protesting in front of a witness, huh?" Then DUGGAN states, "ya." ALBERT claims to police, "I felt anxious, nervous thought it was going to ruin my business for the day. Fearful that they all might try to enter my store then what would I do. It was unsettling to be honest." ROCCO, Jenna and DUGGAN, Timothy could be seen matching this description inf the video that Officer Chin took. We cleared the area and I proceeded to keep watch of them from a distance as they continued to picket in the same area. My WatchGuard cruiser camera was activated. It depicts picketers completely leaving the area at approximately 1437hrs when I cleared via radio transmission. These individuals were also seen posing for a group picture on Turtle Boy's official website in a blog titled: "Canton Cover-Up Part 204: Canton Police Threaten To Arrest Peaceful Protesters From Being In "Eyeshot" Of D&E Pizza Because Chris Albert Was Witness To A "Criminal Crime." The photograph of this group photo is uploaded to the report.
- In the video that Officer Chin took using CAN 686's cruiser mounted laptop unit, ENOS, Jessica (previous name
  of SVEDINE, Jessica) could be seen holding what appeared to be a stack of business cards that stated "FREE

KAREN READ." She offered me one by holding the stack out and stating, "would you like one?" at time stamp 1 minute and 6 seconds. After, ENOS did in fact hand one to a pedestrian. This could be seen on the video recording that Officer Chin took on scene. ENOS was wearing a black Nike brand sweatshirt and blue jeans holding a sign that said 'justice'. SILVA, Roberto can also be seen in the video that Officer Chin took wearing an orange shirt that states "FREE KAREN READ" and wore a black hat and dark colored pants. He held a sign that stated, "have you all found that ford edge yet or nah? #FreeKarenRead." He was identified by a public tip to police. I queried SILVA, Roberto in CJIS and identified him based on his driver's license photo as well as his most recent firearms license photo which was issued on 07/25/23.


- 9. I transferred the two photographs and one video that ALBERT emailed to my town email address onto a thumb drive and entered it in as evidence. It was placed into evidence locker #10. Driver's license photographs of those involved, as well as SILVA'S firearms photo, and the group photograph depicting the suspects (except SILVA) are attached to this report as evidence. Still shots from the video are also uploaded to the report.
- Several individuals picketing could be seen in the video that Officer Chin recorded holding their cellphones as if they were video recording while they were in the commission of committing the crime of Massachusetts General Laws: Chapter 268 Section 13A during the time that officers were on scene. These individuals include ONEIL, Meredith; DUGGAN, Timothy; ROCCO, Nicholas; ROCCO, Jenna; and SILVA, Roberto. BRADFORD, Michael could also be seen on this same video apparently taking a photograph with a cellphone while officers were on scene.
- 11. It is believed that the protest escalated to Massachusetts General Laws: Chapter 268 Section 13A: 'picketing court, judge, juror, witness, or court officer' when the individuals involved in the public display were in view of witness ALBERT, Chris while he was inside of his business/ building of D & E Pizza & Subs. It is believed to be more probable than not that the individuals involved in the picketing specifically chose this location because they specifically intended to target/influence said witness ALBERT, Chris by being visible from the business while ALBERT occupied the business/building. Based on the statements that ALBERT made to police regarding the incident, it is more probable than not that this incident had an influence on him.
- 12. It is also believed to be more probable than not that the picketers intended to impede, obstruct, and delay this criminal investigation by not identifying themselves when requested by law enforcement on-scene, causing officers to have to resort to other means of identifying them in order to file criminal charges, which is a violation of Massachusetts General Laws: Chapter 268 Section 13B.

#### **DEFENDANT KAREN READ'S MOTION TO DISMISS**

Now comes the Defendant Karen Read, by and through undersigned counsel, and herely moves this Honorable Court, pursuant to the Fifth, Sixth, and Fourteenth Amendments to the United States Constitution and Article 12 of the Massachusetts Declaration of Rights, to dismiss Counts 1 and 3 currently pending against her on the grounds that the jury reached a unanimous decision to acquit her on those charges and, alternatively, because there was no manifest necessity supporting the declaration of a mistrial with respect to the charges on which the jury had agreed that Ms. Read was not guilty and that therefore a retrial on such counts would violate the Double Jeopardy protections of both federal and state constitutions.

The ancient right to a jury trial is no mere "procedural formalit[y] but [rather a] fundamental reservation[] of power to the American people." *Erlinger v. United States*, No. 23-370, 2024 WL 3074427, at \*6 (June 21, 2024) (citation omitted). "By requiring the Executive Branch to prove its charges to a unanimous jury beyond a reasonable doubt, the Fifth and Sixth Amendments seek to mitigate the risk of prosecutorial overreach and misconduct, including the pursuit of 'pretended offenses' and 'arbitrary convictions.'" *Id.* (quoting The Federalist No. 83,

p. 499 (C. Rossiter ed. 1961)). "Prominent among the reasons colonists cited in the Declaration of Independence for their break with Great Britain was the fact Parliament and the Crown had 'depriv[ed] [them] in many cases, of the benefits of Trial by Jury." *Id.* at \*5 (citation omitted). "After securing their independence, the founding generation sought to ensure what happened before would not happen again. As John Adams put it, the founders saw representative government and trial by jury as 'the heart and lungs' of liberty." *Id.* (citation omitted).

It follows that a jury acquittal is entitled to the utmost respect in our criminal justice system. "The Double Jeopardy Clause provides that no person shall 'be subject for the same offence to be twice put in jeopardy of life or limb." *Blueford v. Arkansas*, 566 U.S. 599, 605, (2012) (quoting U.S. Const., Amdt. 5). "The Clause guarantees that the State shall not be permitted to make repeated attempts to convict the accused, thereby subjecting h[er] to embarrassment, expense and ordeal and compelling h[er] to live in a continuing state of anxiety and insecurity, as well as enhancing the possibility that even though innocent [s]he may be found guilty." *Id.* (citation omitted). "Perhaps the most fundamental rule in the history of double jeopardy jurisprudence has been that [a] verdict of acquittal . . . could not be reviewed, on error or otherwise, without putting [a defendant] twice in jeopardy, and thereby violating the Constitution." *Commonwealth v. Taylor*, 486 Mass. 469, 481 (2020) (quoting *United States v. Martin Linen Supply Co.*, 430 U.S. 564, 571 (1977)).

Here, the very day after a mistrial was declared, undersigned counsel began receiving unsolicited communications from three of the twelve deliberating jurors indicating in no uncertain terms that the jury had a firm 12-0 agreement that Ms. Read was not guilty of two of the three charges against her, including the charge of murder in the second degree. Given the central importance that acquittals have held in our criminal justice system for hundreds of years,

the defense respectfully submits that the jury's unanimous agreement precludes re-prosecution of Ms. Read on Counts 1 and 3 and mandates dismissal of those charges. Alternatively, to the extent the Court believes further factual development is required, the defense respectfully requests that a post-verdict inquiry be held on the issue and that the Court authorize defense counsel to seek additional proof from the jurors regarding their having unanimously acquitted the defendant of two of the three charges against her prior to indicating to the Court that they could not reach a verdict on the third charge alone.

#### I. BACKGROUND

On June 9, 2022, Ms. Read was charged via three separate indictments with murder in violation of M.G.L. ch. 265, § 1 (Count 1); vehicular manslaughter in violation of M.G.L. ch. 265, § 13½ (Count 2); and leaving the scene of personal injury or death in violation of M.G.L. ch. 90, § 24(2)(a½)(2). A jury trial began on April 16, 2024. On June 25, 2024, the jury began deliberations.

On July 1, 2024, when the jury presented a note to the Court, all counsel were ordered to the courtroom. See Alan J. Jackson Affidavit ¶ 7. The note was not presented to counsel for review. See id. Rather, the Court indicated that the jury was at an impasse. See id. Once the jury was seated, the Court then read the jury note verbatim in open court and, without providing any opportunity for defense counsel to be heard, the Court declared a mistrial and excused the jury. See id. ¶ 8.¹ In short, neither defense counsel nor the defendant consented to the mistrial

While the jurors' note as read by this Honorable Court indicated the impasse was on "charges," it did not say whether the "charges" were those within Count 2 *i.e.* the multiple ways to find guilt on Count 2 or extended to other Counts. The affidavits attached herein indicate the former not the latter.

and the Court never ascertained from the jury whether its deadlock was in relation to one, two, or all of the charges in the indictments.

The following day, on July 2, 2024, Attorney Jackson was contacted by a juror in this matter ("Juror A") who stated that s/he "wish[ed] to inform [him] of the true *results*" of the jury's deliberations. *Id.* ¶ 4. According to Juror A, "the jury unanimously agreed that Karen Read is NOT GUILTY of Count 1 (second degree murder). Juror A was emphatic that Count (second degree murder) was 'off the table,' and that all 12 of the jurors were in agreement that she was NOT GUILTY of such crime." *Id.* ¶ 5. "[T]he jury also unanimously agreed that Karen Read is NOT GUILTY of Count 3 (leaving the scene with injury/death)." *Id.* ¶ 6.

Another day later, on July 3, 2024, Attorney Yannetti was contacted by "two different individuals (hereinafter, 'Informant B' and 'Informant C') who had received information from two distinct jurors (hereinafter 'Juror B' and 'Juror C') both of whom were part of the deliberating jury in this case." David R. Yannetti Affidavit ¶ 2. Informant B sent Attorney Yannetti "a screenshot he/she had received from someone (hereinafter, 'Intermediary B') of text messages that Intermediary B had received from Juror B. In that screenshot, Juror B texted the following to Intermediary B: 'It was not guilty on second degree. And split in half for the second charge. . . . I thought the prosecution didn't prove the case. No one thought she hit him on purpose or even thought she hit him on purpose [sic]." Id. ¶ 4. Informant C had been in contact with another individual ("Intermediary C") who is a co-worker and friend of Juror C and joined a Zoom meeting during which Juror C discussed the trial. Informant C sent Attorney Yannetti the below screenshots of his/her text messages with Intermediary C regarding what Juror C revealed in the Zoom meeting:

Intermediary C: "no consideration for murder 2. manslaughter

started polling at 6/6 then ended deadlock @ 4no8yes."

. . . .

Informant C: "interesting. if it was no consideration for

murder two, shouldn't she have been acquitted on that count. and hung on the remaining chargers [sic] goes back to the jury verdict

slip that was all confusing"

Intermediary C: "she should've been acquitted I agree. Yes, the

remaining charges were what they were hung

on. and that instruction paper was very

confusing."

*Id.* ¶ 10.

#### II. ARGUMENT

A. The Jury's Unanimous Conclusion that Ms. Read Is Not Guilty on Counts 1. and 3 Constitutes an Acquittal and Precludes Re-Prosecution

"[W]hat constitutes an 'acquittal' is not to be controlled by" the form of the action in question. *Taylor*, 486 Mass. at 482 (quoting *Martinez v. Illinois*, 572 U.S. 833, 841-42 (2014)). "Rather, [the Court] must determine whether" the action "actually represents a resolution, correct or not, of some or all of the factual elements of the offense charged." *Commonwealth v. Babb*, 389 Mass. 275, 281 (1983) (quoting *Martin Linen*, 430 U.S. at 571). The mere presence or absence of "checkmarks on a form" is not dispositive. *Taylor*, 486 Mass. at 482 (citation omitted).

Here, the attached affidavits by Attorneys Jackson and Yannetti reflect statements by three deliberating jurors that the jury had reached a final, unanimous conclusion that Ms. Read was not guilty on Counts 1 and 3. There was nothing tentative about the jurors' statements. To the contrary, they were definitive in describing the result of the jury's deliberations. See Alan J. Jackson Affidavit ¶ 5 ("Juror A was emphatic that Count 1 (second degree murder) was 'off the

table,' and that all 12 of the jurors were in agreement that she was NOT GUILTY of such crime."); David R. Yannetti Affidavit ¶ 4 (reflecting text message from Juror B, "It was not guilty on second degree. . . . No one thought she hit him on purpose or even thought she hit him on purpose [sic]"); Id. ¶ 10 (reflecting Juror C's statement, relayed by Intermediary C, that there was "no consideration for murder 2" and Ms. Read "should've been acquitted" on that count). To hold that this firm conclusion did not amount to an acquittal simply because it was not recorded in a verdict form would be to elevate form over substance in a manner prohibited by the foregoing United States Supreme Court and Supreme Judicial Court precedents.

The Supreme Court's decision in *Blueford* is not to the contrary. There, a juror had reported during deliberations that the jury "was unanimous against" the charges of capital murder and first-degree murder but split on manslaughter. 566 U.S. at 603-04. The court sent the jury back to continue deliberations and, when the jury remained unable to reach a verdict, declared a mistrial. *See id.* at 604. The Supreme Court rejected the defendant's argument that the Double Jeopardy Clause prohibited re-prosecution for capital and first-degree murder. In doing so, the Court relied heavily upon the lack of finality of the juror's report. "[T]he jury's deliberations had not yet concluded," and it "went back to the jury room to deliberate further." *Id.* at 606. Here, by contrast, the jurors' statements reflect a final determination that persisted through the end of deliberations. Even assuming *arguendo*, and contrary to the foregoing, this Court finds that retrial would not be prohibited under *Blueford*, this Court can and should afford broader protection under Massachusetts state law. *See Commonwealth v. Tinsley*, 487 Mass. 380, 391 n.6 (2021) ("Unlike the United States Constitution, the Massachusetts Declaration of Rights does not include a double jeopardy clause, but our statutory and common law have long embraced the same principles and protections." (citation omitted)).

B. Re-Prosecution Is Independently Barred Because There Was No Manifest Necessity to Declare a Mistrial on Counts on which the Jury Was Unanimously Agreed

"[T]he [d]ouble [j]eopardy [c]lause affords a criminal defendant a 'valued right to have h[er] trial completed by a particular tribunal." *Taylor*, 486 Mass. at 483 (quoting *Oregon v. Kennedy*, 456 U.S. 667, 671-72 (1982)). "Thus, where a mistrial is entered 'without the defendant's request or consent,' retrial is impermissible unless there was a manifest necessity for the mistrial." *Id.* (quoting *United States v. Dinitz*, 424 U.S. 600, 606-07 (1976)). Here, Ms. Read did not consent to the declaration of a mistrial. *See* Alan J. Jackson Affidavit ¶ 9; *see also Commonwealth v. Edwards*, 491 Mass. 1, 13 (2022) (rejecting argument "that the defendant consented to the declaration of a mistrial because he did not object when the judge ordered the case dismissed").

Absent the defendant's consent, "State and Federal double jeopardy protections bar, 'as a general rule,' retrial of a defendant whose initial trial ends . . . without a conviction." *Ray v. Commonwealth*, 463 Mass. 1, 3 (2012) (quoting *Arizona v. Washington*, 434 U.S. 497, 505 (1978)). This rule is rooted in "the importance to the defendant of being able, once and for all, to conclude h[er] confrontation with society through the verdict of a tribunal [s]he might believe to be favorably disposed to h[er] fate." *Cruz v. Commonwealth*, 461 Mass. 664, 670 n.9 (2012) (quoting *United States v. Jorn*, 400 U.S. 470, 486 (1971) (plurality opinion)). Accordingly, the "heavy" burden of establishing "manifest necessity" to justify a mistrial is exclusively on the Commonwealth. *Washington*, 434 U.S. at 505. Before a court declares a mistrial for manifest necessity, "(1) counsel must [have been] given full opportunity to be heard and (2) the trial judge must [have given] careful consideration to alternatives to a mistrial." *Ray*, 463 Mass. at 4 (citation omitted).

Here, the defense respectfully submits that the lack of opportunity to be heard is, alone, dispositive. Upon receiving a jury note, the Court declared a mistrial and excused the jury without consulting counsel. See Alan J. Jackson Affidavit ¶ 8. This action "was sudden, brief, and unexpected, neither preceded nor accompanied by discussion with counsel." Commonwea!th v. Horrigan, 41 Mass. App. Ct. 337, 341 (1996); see also Picard v. Commonwealth, 400 Mass. 115, 118-19 (1987) (finding no manifest necessity where "[n]o opportunity was given counsel to argue the propriety of the question or of the necessity of a mistrial"); Commonwealth v. Steward, 396 Mass. 76, 79 (1985) (finding no manifest necessity where "the trial judge . . . first ruled that he was going to declare a mistrial and then, almost as an afterthought, unenthusiastically asked whether counsel objected").

The record is independently lacking on the second prong, as it reflects no "careful consideration" of "alternatives to a mistrial." *Ray*, 463 Mass. at 4 (citation omitted). Here, there was one obvious alternative: to simply ask the jury to specify the charge(s) on which it was deadlocked. Had the Court done so, and the jury articulated its verdict consistent with the statements of Jurors A, B, and C, the Double Jeopardy implications would have been clear and decisive. "[I]ndeed, with virtual unanimity, the cases have applied collateral estoppel to bar the Government from relitigating a question of fact that was determined in defendant's favor by a partial verdict." *United States v. Mespoulede*, 597 F.2d 329, 336 (2d Cir. 1979); *see also Wallace v. Havener*, 552 F.2d 721, 724 (6th Cir. 1977) ("When the jury hands down a partial verdict, a final judgment is rendered on the counts upon which the jury has reached agreement.").

The Supreme Judicial Court's holding, in *Commonwealth v. Roth*, 437 Mass. 777 (2002), that courts should not request partial verdicts on lesser included offenses charged in a single count does not pertain here. As the *Roth* Court acknowledged, "[i]nquiry concerning partial

verdicts on lesser included offenses" that have not been separately charged "carries a significant potential for coercion." *Id.* at 791; see also Blueford, 566 U.S. at 609 (declining to require count "to consider giving the jury new options for a verdict" in the form of partial verdicts on lesser included offenses where, "under Arkansas law, the jury's options . . . were limited to two: either convict on one of the offenses, or acquit on all"). Such inquiry, in effect, implies that the jury should consider conviction on the lesser count. No similar danger is present where, as here, the jury was asked to return three separate verdicts on three separate counts. See Roth, 437 Mass. at 793 n.13 (distinguishing situation "where a defendant has been charged in separate indictments or complaints, each with a separate verdict slip"). In this circumstance, where the jury reports a deadlock without specifying the count(s) on which it has reached an impasse, it is a straightforward (and, the defense contends, Constitutionally required) follow-up to ask whether the deadlock relates to some as opposed to all counts. Indeed, the Supreme Judicial Court has explicitly stated, "[w]here a complaint or indictment, in multiple counts, charges multiple crimes . . . a general verdict could be returned as to one of the counts, despite deadlock on the other counts." A Juvenile v. Commonwealth, 392 Mass. 52, 55 n.1 (1984).

### C. Alternatively, the Defense Is at Least Entitled to Conduct Post-Verdict Inquiry

Undersigned counsel did not initiate the communication with Jurors "A," "B," and "C," which resulted in the disclosure of information that is memorialized in counsel's affidavits that are appended to this motion. Should this Court find that further factual development is required, the defense respectfully requests that the Court conduct a *voir dire* of the jury and/or an evidentiary hearing to substantiate the existence of an acquittal. Should the Court seek the

affidavit of each juror (*i.e.*, jurors "A", "B", and "C" *supra*) the defendant asks for the Court to authorize undersigned counsel to initiate contact for the sole purpose of asking each juror whether the jury had unanimously agreed that the defendant was not guilty of Counts 1 and 3. The Supreme Judicial Court has held that, because of the importance of the issue, "juror bias is a legitimate subject for post-verdict inquiry." *Commonwealth v. McCalop*, 485 Mass. 790, 798 (2020) (citation omitted). It is similarly "a fundamental tenet of our system of justice" that a defendant may not be retried for a crime on which she was previously acquitted by a jury, and the defense submits that post-verdict inquiry is equally warranted in the present context. *Id.* at 790. Just as the Court in *McCalop* approved questions as to the existence of racial bias, questions about a matter more attenuated from the content of deliberations – whether the jury had unanimously concluded that Ms. Read was not guilty of Counts 1 and 3 – do not invade the heartland of jury deliberations but preserve the defendant's precious rights to the favorable outcome of a jury trial and to the protections of the Double Jeopardy Clause and its related state judicial protections.

#### III. CONCLUSION

For the foregoing reasons, Ms. Read respectfully requests that this Honorable Court issue an Order dismissing Counts 1 and 3.
