12 By and through counsel, Plaintiff, Casey Houtsinger, submits an Amended Complaint as a matter  
13 of right per ORCP 23A and alleges as follows:

14 PARTIES AND INTRODUCTION

15 1.

16 Plaintiff Casey Houtsinger (“Plaintiff”) is an individual who resides in Las Vegas,  
17 Nevada, but at all times relevant to this complaint was domiciled in Oregon. Plaintiff has had a  
18 long career as an educator, having worked in California, Wisconsin, Costa Rica and even as far  
19 as Nicaragua. She has volunteered in a variety of roles, including on the Oneida Tribal Service  
20 Board; as a coach for the Milwaukee, Wisconsin Special Olympics; for the Native American  
21 AIDS Project and the San Francisco AIDS Foundation; and as a tutor in the Literacy Services of  
22 Wisconsin, where she tutored a refugee from Myanmar for one year. Plaintiff is herself a  
23 member of the Oneida Nation. See Exhibit 1 (Houtinsger Resume).

24 2.

25 Defendant US Support LLC (“US Support”) is a limited liability company organized  
26 under the laws of Nevada with registered offices at 3157 N. Rainbow #328, Las Vegas, Nevada  
27

1 89108 and a Registered Agent located at 401 Ryland Street, Suite 200 A, Reno, Nevada 89502.  
2 Exhibit 2 (Nevada State Business Record). Among its products and services offerings, US  
3 Support maintains and operates Mugshotsearch.net, a service for searching for online booking  
4 photos accessible at <https://mugshotsearch.net/>. Exhibit 3 (US Support Products & Services  
5 Page).

6 3.

7 Defendant Jason Watson is a natural person and the only listed member of US Support  
8 LLC. Exhibit 2; see also Exhibit 4 (Jason Watson LinkedIn Page). Mr. Watson is believed to be  
9 residing at 2101 Tosca Street, Las Vegas, Nevada 89128

10 4.

11 At least some of the booking photos locatable from Mugshotsearch.net are stored in a  
12 database accessible at <https://arre.st/>, (“Arre.st”) which is also maintained by US Support.  
13 Arre.st is an interactive website, permitting users to register a member profile, post comments,  
14 add new content such as news stories to records of individuals’ arrests, and favorite individuals’  
15 arrest records including their booking photo. Furthermore, Defendants maintain an Arre.st  
16 Facebook page that links to the records accessible through Arre.st. Exhibit 3.

17 5.

18 The photos accessible through Arre.st are also made available to Guess the Charge,  
19 available at <https://guessthecharge.net>, an online game in which players view a booking photo  
20 and try to guess the charge for which the individual depicted in the photo was arrested. Guess  
21 the Charge is also maintained and operated by Defendants. Exhibit 3.

22 6.

23 This case concerns a booking photo of Plaintiff taken at an unfortunate and stressful time  
24 in her life. The photo is accessible on Arre.st and may be located by searching Plaintiff’s name  
25 on Mugshotsearch.net. As will be set forth in more detail below, the underlying charges to  
26 which Plaintiff was booked have been dismissed with prejudice and Plaintiff has paid her debts  
27 to society. She has since repeatedly sought to have the booking photo removed from

1 Defendants' websites to no avail. Defendants have ignored Plaintiff's communications and  
2 appeals for removal, so Plaintiff now seeks a judgment and order from this Court mandating that  
3 Defendants remove the photo from their websites and pay the statutory damages set forth in ORS  
4 133.875.

5 FACTUAL ALLEGATIONS

6 **Plaintiff's Underlying Charge**

7 7.

8 On May 12, 2020, Plaintiff, was experiencing homelessness and lack of employment.  
9 That day, she was arrested for driving under the influence of intoxicants in Josephine County,  
10 Oregon. Exhibit 5 (Information, Josephine County Case No. 20CR63299).

11 8.

12 On December 9, 2020, Plaintiff petitioned and agreed to a DUII Diversion Agreement,  
13 Exhibit 6 (Petition and Agreement), which this Court allowed. Exhibit 7 (Order Re: DUII  
14 Diversion).

15 9.

16 From December 16, 2020, to December 15, 2021, Plaintiff successfully participated in  
17 the Diversion Agreement requiring installation of an ignition interlock device in her vehicle and  
18 completion of a rehabilitation program. Exhibit 7.

19 10.

20 On May 26, 2021, Plaintiff's counselor reported that Plaintiff had successfully completed  
21 the rehabilitation program. Exhibit 8 (DUII Status Report).

22 11.

23 On January 6, 2022, this Court dismissed the DUII charge with prejudice based on the  
24 determination that Plaintiff either fully complied with the diversion program or took sufficient  
25 steps to satisfy the requirement to complete the program. Exhibit 9 (Judgment of Dismissal).

12.

As of the Fall of 2024, Plaintiff has begun her studies at the University of Nevada at Las Vegas to obtain her Masters of Education in their Special Education program, Exhibit 10 (Acceptance Letter), and has plans on proceeding to obtain her Ph.D. next. Plaintiff has paid her debts to society and wishes now to continue giving back through education and care for students with special needs, but the continued presence of the booking photo on Defendants' websites haunts her and leaves her nervous that prospective employers and colleagues may find it and discriminate against her. Plaintiff has already experienced judgment and damage to her reputation as a result of the booking photo.

**Defendants' Acquisition and Use of the Booking Photo**

13.

US Support's website, Arre.st, provides a list of Frequently Asked Questions ("FAQs") at <https://arre.st/Help/FAQ/>. Among the FAQs, are the following:

- 1 • “Q. What is this site?”
  - 2 ○ “A. Arre.st is your fair use periodical public records news reporting and
  - 3 research resource. Arre.st contains public records of private individuals
  - 4 that are of interest to the public.”;
- 5 • “Q. I was acquitted, falsely accused, had my ID stolen, found not guilty, case was
- 6 dismissed, or my record was expunged. Will you delete the booking data?”
  - 7 ○ A. No. All data is collected from official sources and considered to be
  - 8 public record at the time of publishing.”;
- 9 • “Q. Will threat of a lawsuit, or complaints filed with the Attorney General or BBB
- 10 help get data deleted?
  - 11 ○ A. No. These avenues will essentially slow any processing and potentially
  - 12 create additional publicly available records.”; and
- 13 • “Q. Will you, the Arre.st admin, delete a record from the Arre.st website?”
  - 14 ○ A. Only with a valid court order specifying the URL. The court order must
  - 15 be from a U.S Court and not infringe upon any Constitutionally protected
  - 16 rights.”

17 See Exhibit 11 (FAQ Page).

18 14.

19 The Oregon Department of Corrections maintains the Oregon Offender Search website  
20 (“OOS”), which accesses a database of booking photos taken during arrests in the State of  
21 Oregon. OOS is available at <https://docpub.state.or.us/OOS/intro.jsf>. Before permitting a user to  
22 access OOS’s search tool, the website provides a disclaimer that the records therein should not  
23 be considered official.

24 15.

25 Plaintiff’s photo is not available on OOS. Upon information and belief, Plaintiff’s  
26 booking photo was posted to OOS after her arrest but has since been taken down.

1 16.

2 Upon information and belief, Defendants were able to obtain the booking photo from  
3 OOS and copied it into the database accessible by Arre.st.

4 17.

5 Alternatively, Defendants are believed to have obtained Plaintiff's booking photo through  
6 other means. In any case, Plaintiff's booking photo is currently available on Arre.st and locatable  
7 by searching Plaintiff's name on Mugshotsearch.net.



19 18.

20 Upon information and belief, Plaintiff's photo also has been or continues to be used on  
21 the Guess the Charge website.

22 **Plaintiff's Attempts to Remove the Booking Photo**

23 19.

24 Upon discovering her arrest records on Arre.st, Plaintiff reached out at least as early as  
25 January 26, 2021, to request that US Support removed her booking photo. Exhibit 12 (Request  
26 Email).

20.

At least as late as November 22, 2022, US Support permitted individuals whose records were included on Arre.st to purchase a “license key” to the records and use that license key to delete their records, including their photos, from the Arre.st database. Exhibit 13 (Plaintiff’s Email to Tucker Rossetto).

On November 11, 2022, attorney Tucker Rossetto, OSB #154126, sent a letter to US Support and Defendant Watson requesting that they remove Plaintiff’s records from Arre.st per Oregon House Bill 3273 A (2021), now codified at ORS 133.875, which necessitates compliance with booking photo removal requests. Exhibit 15 (Letter to Defendants). The letter was resent to

1 Defendants at a second address after Plaintiff discovered the address of US Support's registered  
2 agent. Exhibit 14 (Letter to Defendants). Defendants failed to respond to either letter.

3 22.

4 Through the years that the photo has remained on the Arre.st website, Plaintiff has grown  
5 increasingly concerned about her long-term prospects and taken dramatic action to seek the  
6 removal of her arrest record from the website. She has engaged Representative Janelle Bynum  
7 for legislative assistance, sought assistance from legal aid services, obtained the services of Mr.  
8 Rossetto as described above, and been in contact with the Oregon Department of Justice seeking  
9 their assistance. Her job prospects and reputation have been and are likely to continue being  
10 harmed by the actions and omissions of Defendants. She now turns to this Court for relief.

11 CLAIMS FOR RELIEF

12 **Claim 1**

13 **Failure to Remove Booking Photo**

14 **(ORS 133.875)**

15 23.

16 Plaintiff hereby incorporates all previous paragraphs and all exhibits referenced therein as  
17 if realleged here.

18 24.

19 At all times relevant to this action, Defendants Watson and US Support are or were  
20 responsible for operating a publish-for-pay publication as defined in ORS 133.875(3).

21 25.

22 As described above, Defendants received Plaintiff's request for the removal of her  
23 booking photo from their website at least as early as January 16, 2021, and no later than  
24 November 27, 2023.



1 26.

2 Defendants have failed to respond to Plaintiff's request, and as of the time of filing, their  
3 license-key-based removal system has been removed from their website.

4 27.

5 Defendants were notified at least as early as November 27, 2023, that the charges for  
6 which Plaintiff was arrested were acquitted, not prosecuted, set aside, vacated, or pardoned.

7 28.

8 Defendants are thus in violation of ORS 133.875 and liable for (1) statutory damages of  
9 at least \$500 per day and at most \$1,000 per day after receipt of Plaintiff's request, and (2)  
10 attorneys' fees in an amount to be calculated at trial.

11  
12 PRAYER FOR RELIEF

13 THEREFORE, plaintiff requests this Court enter judgment and order granting the  
14 following relief:

- 15 1. A judgment that Defendants' actions and omissions described above constitute a  
16 violation of ORS 133.875;  
17 2. A damages award of statutory damages, costs of the action, and attorney's fees in  
18 an amount to be calculated at trial.



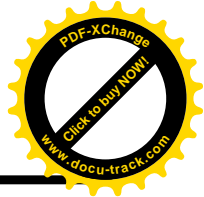
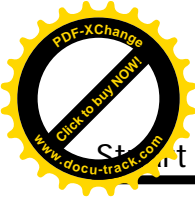

That bill requires organizations such as yours to remove a photo within 30 calendar days of a person's request to have it removed. **This letter is to serve as Ms. Houtsinger's request that all entries associated with her on your website and Facebook page be removed.** Please be aware that HB 3273 allows for individuals to take legal action if the 30-day timeline is not adhered to, for them to collect legal fees associated with said action, and for the imposition of statutory damages of \$500 per day until the situation is remedied.
