**ORDER GRANTING DEFENDANT  
DAPHNE WILLIAMS’S ANTI-SLAPP  
SPECIAL MOTION TO DISMISS FIRST  
AMENDED COMPLAINT UNDER NRS  
41.660**

18 Defendant Daphne Williams’s Anti-SLAPP Special Motion to Dismiss Plaintiff William  
19 “Randy” Lazer’s First Amended Complaint Under NRS 41.660, having come on for hearing on  
20 December 9, 2019 at 9:00 a.m., and the Nevada Supreme Court having issued its decision in  
21 *Williams v. Lazer*, No. 80350, 137 Nev. Adv. Rep. 44 (Nev. Sept. 16, 2021) reversing and  
22 remanding with instructions to grant Defendant’s special motion to dismiss, and remittitur having  
23 issued,

24 IT IS HEREBY ORDERED that Defendant’s Anti-SLAPP Special Motion to Dismiss  
25 First Amended Complaint Under NRS 41.660 is GRANTED.

26 IT IS FURTHER ORDERED that Plaintiff William “Randy” Lazer’s claims against  
27 Defendant asserted in his First Amended Complaint are hereby dismissed with prejudice.

1 IT IS FURTHER ORDERED that a final judgment is hereby entered against Plaintiff in  
2 favor of Defendant.

3 IT IS FURTHER ORDERED that Defendant is entitled to an award of costs and  
4 reasonable attorneys' fees pursuant to NRS 41.660(1)(a) and may be entitled to an additional  
5 award of up to \$10,000 pursuant to NRS 41.660(1)(b). Defendant may file a bill of costs and a  
6 motion for costs and attorneys' fees seeking these amounts no later than 21 days following service  
7 of written notice of entry of this Order.
